THE FOLLOWING DRAWING IS INTENDED FOR PARTICIPATION IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO U.S. LAW. DO NOT ENTER THIS DRAWING IF YOU ARE NOT LOCATED IN THE U.S. OR DISTRICT OF COLUMBIA AT TIME OF ENTRY.

1. No Purchase Necessary. Making a purchase will not improve your chances of winning a prize.
